



DISCLOSURE OF ELECTRIC LINE CHARGES

Top Energy is required by law to disclose details of line charges.

1. Standard Tariff charges comprise a Fixed Network charge and a variable charge based on units distributed.
2. "Price on Ice" Tariff charges comprise a Fixed Network charge and a variable charge based on units distributed. These contracts will still apply between Contact Energy and their customers.
3. Industrial Tariffs for large consumers are customer specific and wholly fixed charges.
4. Unmetered supply tariffs are wholly fixed.

All prices are GST exclusive.

NB: These are only the Line charges. In most cases they are charged to an energy trader. Top Energy has no influence as to how the energy trader passes on those charges to their customers.
